#### Turbulence and CFD models: Theory and applications Hands-on session 1 and 2

#### Task 1

Based on the cases used in tutorials 1 and 2, you are asked to reproduce the plots shown in figures 1 and 2.



Figure 1: Laminar and turbulent physical velocity profiles. The units of normal distance y are meters. The units of the velocity U are m/s.

Using a Reynolds number different from 100 000 and 500, you must plot the following information,

- Physical velocity profile of a laminar case.
- Comparison of the physical velocity profile of the laminar case against the Hagen-Poiseuille solution.
- Physical velocity profile of a turbulent case.



Figure 2: Non-dimensional turbulent velocity profile  $y^+$  vs.  $U^+$ .

- Comparison of the physical velocity turbulent profile against the powerlaw profile. Remember, the coefficient of the power-law equation must be calibrated according to the Reynolds number.
- Plot the non-dimensional turbulent velocity profile  $y^+$  vs.  $U^+$ , and compare it against the analytical correlations (viscous sublayer, loglaw layer, and Spalding law). You must plot two numerical profiles, one corresponding to a wall resolving solution and the other one corresponding to a wall modeling solution (as shown in figure 2).

You must also write a small overview of your case setup, that is, turbulence model used, mesh used, boundary conditions, discretization schemes, solution method, average and maximum  $y^+$ , mass flow balance, and so on. You can also add a few sections and cut-plane images showing the contours of velocity, pressure, turbulent kinetic energy, and so on.

## Task 2 (optional)

If you want to go for the extra mile, you can try to complete the following tasks,

- Compare the non-dimensional profiles for different turbulence models.
- Besides Spalding's law, there a few more analytical profiles. Can you plot another one? Do not forget to write down the equations.
- Compare the outcome of the COUPLED method against the outcome of the SIMPLE method. Is the computing time the same? Is the accuracy the same? Which method has the lowest cost per iteration?
- Where do the laminar sublayer profile intersects the log-law profile? Use the same coefficients as the ones used in the lecture notes.
- Compute the pressure drop along the axis of the pipe and compare it against the analytical correlation.
- Determine at what distance along the pipe's axis the flow becomes fully developed in the numerical solution and compare this value with the analytical correlation for entrance length.

### General guidelines

- For plotting, you can use Matlab, Python, GNUPLOT, or EXCEL.
- It will be highly appreciated if you deliver your homework in a Python notebook (this is not compulsory). At the following links, you can find a few examples of Python notebooks reports,
